Discussion involving activities for the Saturday field clean up

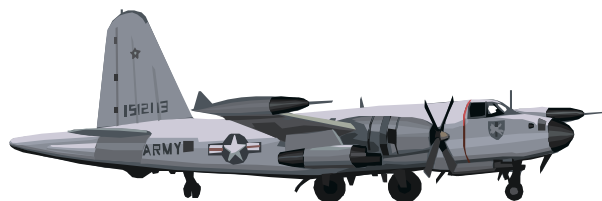
Darrel commented that he would serve dinner at the June field meeting
